### **Purpose of the Job**

To drive Authority's vehicles and transport authorized personnel for official purposes assigned from time to time.

### **Duties and Responsibilities**

- i. Driving motor vehicle as authorized.
- ii. Carrying out routine checks on vehicles.
- iii. Maintaining work tickets for vehicles assigned.
- iv. Ensuring security and safety for the vehicle on and off the road.
- v. Ensure adherence on motor vehicle inspection schedules.
- vi. Timely reporting of accidents and follow up of police abstract.
- vii. Ensuring safety of persons and/or goods in the vehicle.
- viii. Maintaining cleanliness of the vehicle.

## Minimum Academic, Professional Qualifications and Experience

- iii. Valid driving license free from any current endorsements and valid for any of the classes of vehicles or plants which the officer is required to drive.
- iv. Passed Occupational Trade Test for Drivers Grade III from Kenya Institute of Highway and Building Technology (KIHBT) or Ministry of Roads and Public Works.
- v. First-Aid Refresher Certificate Course lasting not less than one (1) week from St. John Ambulance or Kenya Institute of Highway and Building Technology (KIHBT) or any other recognized institution.
- vi. Passed Suitability Test for Drivers Grade III from Kenya Institute of Highway and Building Technology or Ministry of Roads and Public Works.
- vii. Defensive Driving Certificate
- viii. Meets the provisions of Chapter Six of the constitution.
